

## Spring 2022 Conditions of Admission Transfer Students

Congratulations! Your academic achievements have earned you admission to the University of California, Merced. You must submit a Statement of Intent to Register (SIR) by **Nov. 11, 2021,** or the date shown in the MyAdmissions section of the <u>UC Merced Connect platform</u>, in order to secure your admission to UC Merced. Failure to submit your SIR may result in your admission being withdrawn.

Before submitting your SIR, please read and make sure you understand the Conditions of Admission listed below. Submitting your SIR and accepting this offer of admission signifies your acknowledgment that **failure to satisfy any of the conditions listed below will result in UC Merced withdrawing the offer of admission.** Please note that the \$250 SIR deposit is nonrefundable, even if your offer of admission is withdrawn.

Our admission decision was based on the information you reported in your application. Applicants are solely responsible for the accuracy and completeness of all academic information they report to UC Merced.

Therefore, if the self-reported information in your application or any updates are inconsistent with your actual grades and courses, it will result in cancellation of admission and may jeopardize future admission to any campus of the University of California. As indicated in Condition No. 1 below, any changes in your information or low grades must be reported to the Office of Admissions immediately, regardless of whether you believe your admission will be affected.

Although UC Merced maintains the right to withdraw any offer of admission if any of the conditions listed below are not met, if you make us aware of any low grades or changes, we may be able to suggest alternatives in the event your admission appears to be jeopardized. Report any low grades and changes by completing the My Course Updates form on UC Merced Connect at connect.ucmerced.edu/student.

## **Transfer applicants must:**

Maintain eligibility and notify us of any changes to your academic history. Complete all courses
you indicated as "in progress" or "planned" with grades of C or better, unless the selection
criteria for your major indicates otherwise. If you receive a C-, D, F, W, NP or NC grade, add or
withdraw from any courses or enroll in a college other than previously indicated, you must notify
the Office of Admissions immediately by posting the changes to My Course Updates on UC
Merced Connect (connect.ucmerced.edu/student).

Please note: We strongly discourage you from changing your schedule. Also note that one D, F, NP or NC grade in your current term may cause you to be ineligible for admission to the University of California.

As a reminder, UC Merced will accept Pass or Credit grades for admission purposes in major preparatory coursework completed in winter, spring and summer and fall 2020, as well as spring and summer 2021 for all majors, as long as the Pass or Credit grade is equivalent to a C (2.0 or better).

2. Be in good standing (minimum 2.0 grade-point average) at your last institution and in your last term, including summer session.



3. Ensure that final, official transcripts from all high schools and higher education institutions you have attended through Fall 2021 are submitted to the Office of Admissions. Transcripts must be received by **Jan. 10, 2022**. Final official transcripts must show grades received for the fall term.

If you or your college(s) cannot comply with these conditions, you must notify the Office of Admissions in advance, by email or telephone.

If you have attempted college or university level coursework at an institution outside the U.S., all college or university academic records (transcripts) must be sent in a sealed envelope directly from the institution in the original language, along with English translations.

- 4. If listed in the checklist section of <a href="UC Merced Connect">UC Merced Connect</a>, ensure that any additional requirements such as, but not limited to, submission of AP exam scores are received by the Office of Admissions by <a href="Jan. 10">Jan. 10</a>, <a href="2022">2022</a>, unless another date is specified in your Checklist on UC Merced Connect. This includes official results of external examinations such as International Baccalaureate (IB), A-Level examinations, or language proficiency exams such as TOEFL or IELTS.
- 5. Your fall term must end prior to the end of December, and you must not be enrolled in a winter intersession at any other college or university.
- 6. <u>If you have been admitted to UC Merced as a sophomore-level transfer student</u>, ensure that any required test scores are submitted to the Office of Admissions by **Jan. 10, 2022**.
- 7. Register for courses by Jan. 10, 2022.
- 8. Adhere to the <u>UC Merced student code of conduct</u> (beginning the day you submit your SIR).

If you need to report a D, F, NP or NC grade received, or if you have withdrawn from or dropped a course, please self-report in My Course Updates on UC Merced Connect by Jan. 5, 2022.
